Please read the following instructions:

- 1. The need to follow the manufacturer's assembly instructions in detail to ensure the safety features of the cot are not compromised;
2. The need to ensure the cot is placed at a reasonable distance from curtains, blinds, heaters and power points; and
3. The need to keep medication, string, elastic, small toys or small items such as money out of reach from any position in the cot.

The TouchWood Safety Cots / Care and Maintenance

We advise that all bolts should occasionally be checked that they are securely fitted and tightened.

All TouchWood Safety Cots are stained, sealed and lacquered and finally waxed with non-toxic products. All of these products meet the Safety Standards for Nursery Furniture.

GUARANTEE

All TouchWood Safety Cots are guarantee against faulty materials and workmanship. Should an item be deemed defective due to faulty materials or workmanship, it will be replaced or repaired at TouchWood's discretion.

The guarantee excludes damage caused by misuse, neglect, accident and normal wear and tear.

IMPORTANT NOTICE FOR COT OWNERS

Recommended Mattress Size: This cot has been manufactured for use with a mattress which measures 1300mm (L) x 690mm (W) x 150mm (D) maximum. The width and length are specified because it is important that the gaps between the mattress base and the sides and ends of the cot will not exceed 25mm. This is to minimize the risk of the child's limb becoming caught in the gap. The thickness of the mattress has been specified to ensure that the depth of the cot is greater than 500mm, to minimize the risk of the child climbing or falling out of the cot.

The below notices are affixed to all TouchWood Cots. It is important that the warnings be observed. Should any problems arise, please quote the Batch Number of your cot.

WARNING: TO PREVENT FALLS THE MAXIMUM MATTRESS THICKNESS SHOULD NOT EXCEED 150 MM
RECOMMENDED MATTRESS SIZES: 1300mm x 690mm. DEPTH OF MATTRESS 150mm MAXIMUM
